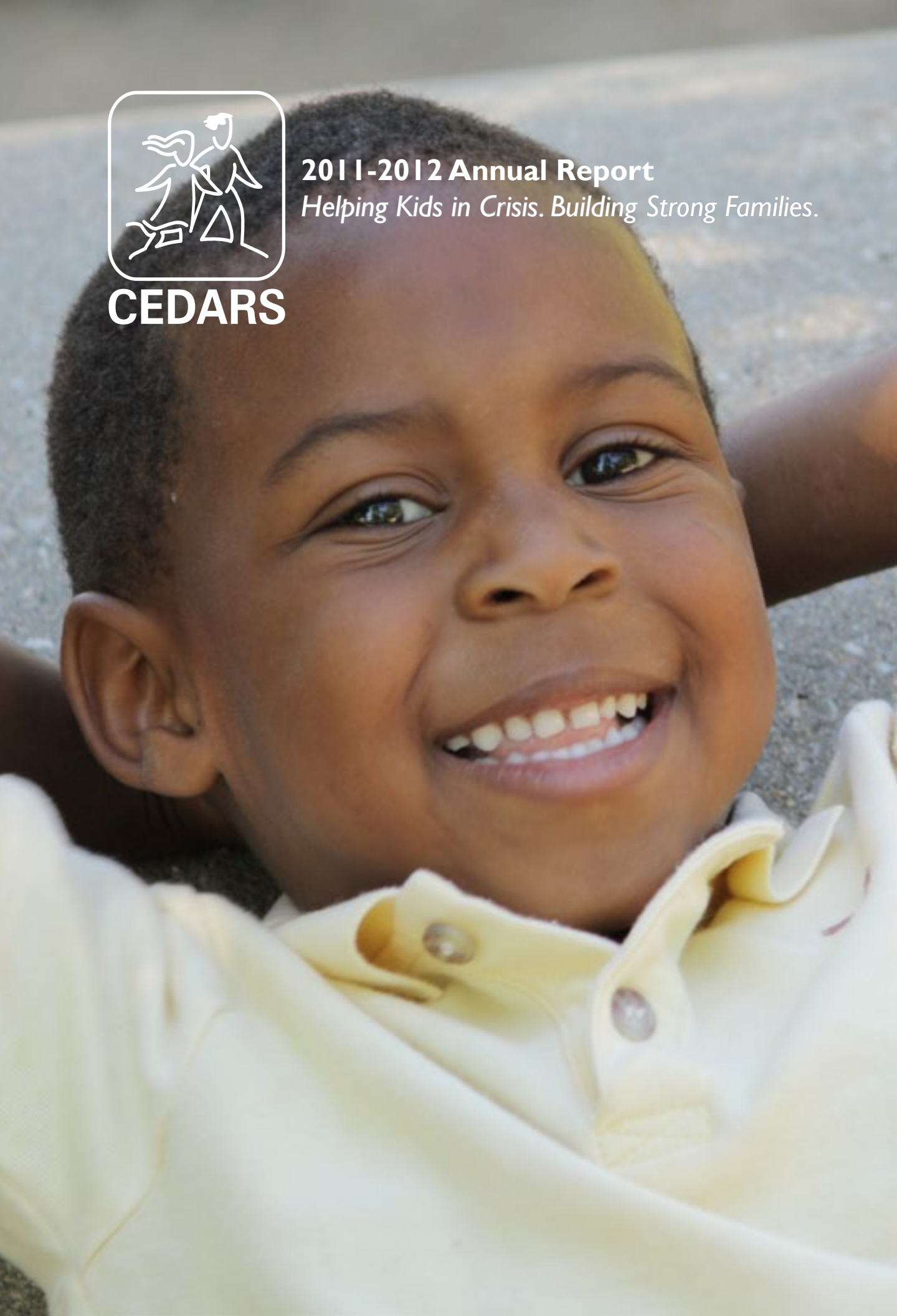

President's Message

Dear Friends,

On August 31, a nineteen year-old man sat in a courtroom and waited for a judge to determine the future of his fifteen year-old brother. For almost a year, he had pled with caseworkers, lawyers and county officials to allow him primary responsibility over his brother's care. At a young age, their mother had passed away and their father, who struggled with a drug addiction, quickly relinquished guardianship. For years, the boys lived separate from their only family—each other.

When the oldest brother gained independent legal status, he immediately focused his energy on his brother. Last month, the courts put their faith in this nineteen year-old to care for his younger brother.

But he can't do it alone.

Thanks to your support, CEDARS foster care staff are able to provide these two young men with the support they will need to be successful.


CEDARS started 65 years ago licensed to care for 30 children in one home. Our efforts hinged on a strong community of donor support.

The landscape of caring for children who have been abused, neglected and homeless has changed a lot since 1947. As a society we continue to evolve in our understanding of what children need to succeed. Our emphasis has dramatically changed to ensure that children experience the normalcy of being part of a family. We've learned to empower, educate and provide resources for struggling families—knowing that kids are most successful when they are able to stay with their family of origin.

This year, CEDARS served over 2,300 youth through out-of-home services, early childhood development centers and preventative services. More than ever we depend on the generosity of community members like you.

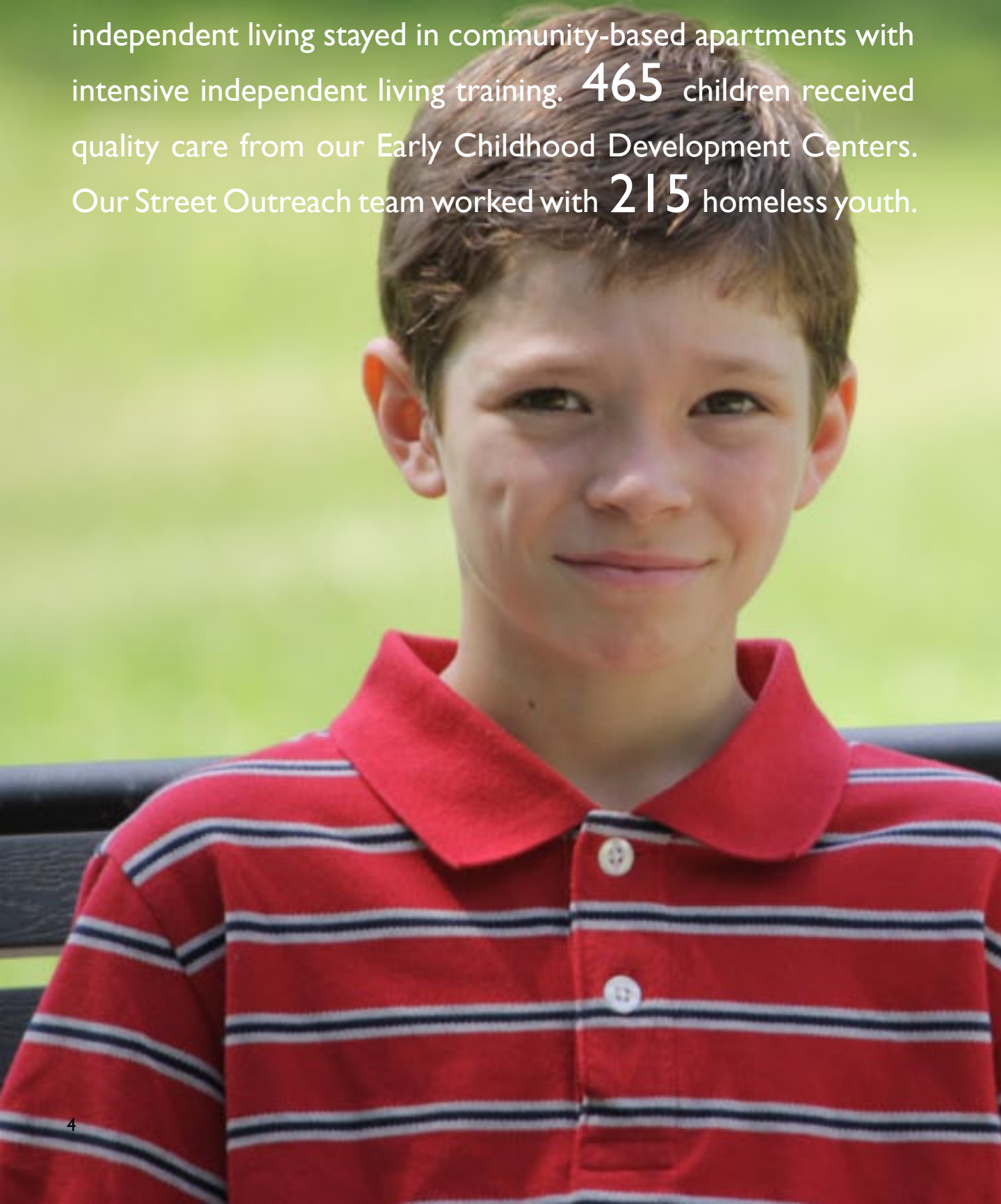
Thank you for continuing to grow with us. And thank you for caring for the children in our community.

2,388 children received support. Children had a safe shelter for 168,535 nights. 64 youth transitioning to independent living stayed in community-based apartments with intensive independent living training. 465 children received quality care from our Early Childhood Development Centers. Our Street Outreach team worked with 215 homeless youth.

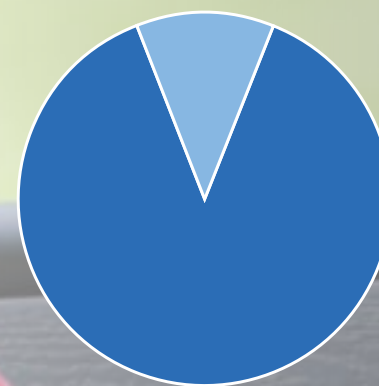
